On 17th September 2024, the Department of Economics and Commerce of Pandit Sushil Ratna Government College, Jawalaji, jointly organized a seminar on the topic "GST and Direct Tax." The event was aimed at enhancing the knowledge and awareness of students regarding the Indian taxation system, with a special focus on various components of Direct Tax. The seminar commenced with a welcome address by faculty members of both departments, emphasizing the importance of understanding tax regulations in today's economic landscape. The key speaker for the session was Dr. Anupam, who delivered a detailed explanation on Form 16, its components, and its relevance in the context of salaried individuals. His session was highly informative and practical. He explained how individual can use it while filing income tax returns. Following this, students of B.Com Final Year actively participated by giving Power Point Presentations on various aspects of Direct Taxation. The topics covered included:

 Exempted Income: Students explained various categories of income that are exempt under the Income Tax Act, such as income from charitable institutions, scholarships, and allowances under Section 10.

 Agricultural Income: The nature of agricultural income, its treatment under tax laws, and conditions under which it is exempt from tax were thoroughly discussed.

 Income from House Property: The students presented an analysis of how income earned from house property is calculated and taxed, including the concepts of Gross Annual Value, Net Annual Value, and permissible deductions.

Income from Salary: A comprehensive presentation was given on how salary income
is taxed, including allowances, perquisites, and deductions under Section 16.

 Exemptions and Concessions: The presentation highlighted various exemptions and rebates available under Sections like 80C, 80D, and 87A, which help reduce the tax burden of individuals.

The seminar was conducted under the academic supervision of Dr Anil Kumar and Professor Praveen Prakash, Head of the Department of Economics. Both of them guided the students throughout the preparation and presentation process. He emphasized the importance of such academic activities in bridging the gap between classroom learning and real-world application. Overall, the seminar and workshop proved to be an enriching experience for the students and faculty alike, enhancing their knowledge of tax laws and encouraging analytical thinking and public speaking skills.
